#### **Recent Cases of Interest**



Eighth Circuit Holds that Employer May Terminate Employee for Misconduct Caused by Disability.



Minnesota Supreme Court: Reasonable Reliance on Outside Counsel's Advice Justified Contract Interference. In March 2015, the Eighth Circuit Court of Appeals decided a case in which a terminated employee, who suffered from bipolar disorder, brought action against her former employer after termination alleging disability discrimination in violation of the Americans with Disabilities Act and the Minnesota Human Rights Act. The Court affirmed the trial court's holding that 1) the behavior of the employee violated reasonable, job-related conduct standards, and the employee failed to demonstrate that she was able to perform the essential functions of her position; and 2) the employer was not liable under the ADA for its failure to accommodate the employee when the employee failed to make a request for accommodation known to her employer.

The Minnesota Supreme Court recently decided whether the justification defense to a claim of tortious interference with a contract may be satisfied by reliance on incorrect advice of counsel. The court decided the defense is satisfied upon a showing of a reasonable inquiry and an honest reliance on the advice.
